5. **FINANCIAL REPORT** (Treasurer's report, financial balance sheet and full accounts are available on request).

JC distributed copies of the Financial Report and had copies of the full accounts available for inspection. The region currently had funds £300 up on last year and were enough for start up costs for the new season's racing. There is a possible sponsor for the Surrey schools medals which would save us £800 next year. The affiliation fee cheque from SSE had bounced and they would be making a BACS transfer payment.

Currently LSERSA were not insuring their equipment as this was a cost of £400 per year and so far we have made savings of £1,200. It was agreed by all that we would continue to not insure this as with depreciation payout we could save this money to purchase new equipment if required.

SSE continue to check the accounts. The Lloyds Bank account is now up and running again after many problems and JC and SV are signatories.

No capital expenses were made this year. Purchases needed to be made for poles and for fixing the traffic light equipment.
